

REA Board Meeting Minutes May 17, 2016 6:00 p.m.

 Krista called the meeting to order at 6:05pm.
- 2. Parent Open Forum
- 3. Principal's Report

Deborah shared the MOU for the buses. Deborah is happy with the MOU and anticipates it answers questions from our April meeting. The MOU does not have a space for storage specified. The buses are insured by the school district in case of vandalism. The buses are at District Transportation now. Deborah has suggested that a Renaissance logo would be a good way to market our school. Elise suggested that she can ask a friend who has a car wrap. Deborah will ask District Transportation how to go about getting a logo on the buses.

The word has been put out to apply for scholarships. To date 5 families with multiple students have been awarded scholarships, 3 single families (14 students total), with a few more that may still apply. Currently for a total of \$5,000. The money will be transferred in the fall.

4. Event Updates

a. Life is Art 2017

Jennifer reported that March 4 is the date for 2017 Life is Art. She was advised to contact Andrea to get the date on the school calendar. Jennifer asked how to submit a budget in line with previous years. Krista recommended to bring that back in the fall as well as goal setting. At that time, Deborah will make recommendations on fundraising priorities. Jennifer reported that they sent out a survey regarding comments from the 2016 event. The biggest question that was brought up was, "where does the money go?" Jennifer has ideas to personalize the school needs to drive higher participation. Jennifer reported that she and Robin have reported that they would like to move the event to Plum Creek to keep the event new and fresh. The venue is available. There are several ways to offset the cost if there is an increase due to change in venue. There will be a push for more sponsorship. Krista cautioned that corporate sponsorships would need to be approved by the REA Board. Jennifer would like to create a Life is Art Facebook page. Krista suggested that Life is Art should work in coordination with Bootcamp as to not cross over on corporate sponsorships. Plum Creek will do passed hors d'oeuvres and dessert for \$25. Krista suggested to consider the layout of the Plum Creek venue in regards to the public restaurants open in the facility. Plum Creek facility fee is \$500. Ticket price would stay the same and ticket sales would cover the cost of the event. Plum Creek can do full bar for \$5-\$6. Elise suggested that sponsorships are a completely untapped aspect to the event. Krista will send Jennifer and Robin the operations guide in the next couple days. An REA Board liaison will be elected tonight and passed along to Jennifer and Robin. Deborah wanted everyone to know not to be afraid to strike out new ground! Krista motioned to

approve the \$500 deposit for 2017 Life is Art at Plum Creek. Amy seconded the motion. All in favor. None opposed.

b. Bootcamp 2017

Britnee and Katie distributed a Bootcamp 2017 proposal. The proposal is to retire Bootcamp as we know it due to increased operating costs in addition to other challenges outlined in the attached proposal. Ideas were presented also on the attached proposal. Krista asked about the date. Deborah suggested that the day before Fall Break has worked out well. Voyages are not out that week. Lots of tips and feedback was shared regarding the logistics of how to manage a "fun" run. Krista shared the same sponsorship concerns that were shared with Life Is Art and to collaborate with them.

Spirit Gear for August, 2016

Debbie Duhon (Vandersnow) and Krista agreed to have a Crew Wear kickoff sale at the Carnival. The Spirit Gear will be "gear" oriented. Debbie asked about a backpack and Elise suggested a small daypack. Debbie is not sure if there is a minimum order per item. Melissa will liaise with Debbie over the summer.

a. Innovative Classroom grants to teachers

Elise motioned to nominate Amy for President. Becca seconded the motion. Amy accepted a nomination to be President. All in favor. None opposed. Amy motioned to nominate Melissa for Treasurer. Becca seconded the motion. Melissa accepted a nomination to be Treasurer. All in favor. None opposed. Krista motioned to nominate Elise for Vice President. Becca seconded the motion. Elise accepted a nomination to be Vice President. All in favor. None opposed. Cari motioned to nominate Becca for Secretary. Amy seconded the motion. Becca accepted a nomination to be Secretary. All in favor. None opposed.
